CONDITIONS OF PARTICIPATION

For the Trade Fair Show "Meet Your Agent – Back To Travel 2022" at the Rheintal-Congress-Center Bingen

DEFINITIONS

Tourexpi GmbH as the organizer of the MESSE will be referred to as "TOUR" in the following. Exhibitors are referred to as "EXH" in the following. The Trade Fair Show "Meet Your Agent - Back to Travel 2022" will be called "FAIR" in the following. The Rheintal-Kongress-Zentrum Bingen will be called "HALLE" in the following.

ADDRESS

Place of the Trade Fair Show is the **Rheintal-Kongress-Zentrum in Bingen, Am Rhein Nahe Eck / Museumsstraße 3, 55411** Bingen am Rhein.

OPENING HOURS

The FAIR will take place from Thursday, May 19th to Friday, May 20th, 2022. A B2C fair for exhibitors will follow on Saturday, May 21, 2022. At the same time, an optional excursion program will be offered for the participating travel agency representatives, which will also take place on Sunday, May 22, 2022.

The hall and the foyer of the Rheintal-Kongress-Zentrum will be open to exhibitors at 8 a.m. in the morning. Since the tables and chairs of the "stands" will already be set up, the exhibitors can set up their roll-ups and give-aways and any other items by the start of the FAIR and also dismantle them at the end of the FAIR. Set-up and dismantling days are not required.

The B2C fair on Saturday, May 21, opens at 10:00 a.m. and closes at 5:00 p.m. for the public Exhibitors have access to the hall and the foyer one hour before and one hour later.

ATERIAL DELIVERY

Exhibitor roll-ups and give-aways can be sent to the caretaker of the Rheintal-Kongress-Zentrum during the week in which the FAIR takes place. **Address**: Rheintal Congress Center in Bingen, Am Rhein Nahe Eck / Museumsstrasse 3, 55411 Bingen am Rhein, to the attention of Mr Herbert. Materials that are easy to carry can also be carried from the "Museumstrasse" and "Gerbhausstrasse" car parks from a maximum distance of 100 meters.

SALES

Selling of goods and services is allowed in general. All goods and services offered have to show a price tag. Prices have to include German VAT and all additional costs.

APPLICATION / CONFIRMATION

The registration (participation and stand order) for the FAIR is made using the registration form, which must be completed in full and signed in a legally binding manner. This registration is a contractual offer by the exhibitor, which requires acceptance by the TOUR. The sending of the registration form does not justify a claim for admission. The written confirmation of participation from the TOUR, stating the stand provided (stand confirmation) and the enclosed invoice for participation, is considered admission to the event. If the content of the stand confirmation deviates from the content of the exhibitor's registration, the contract shall come into effect in accordance with the stand confirmation, unless the exhibitor objects in writing within two weeks.

EXHIBITOR PASSES

The number of exhibitor passes depends on the number of booked stands (cf. P. 3, Stand Dimensions and Services included). The exhibitor will be given 2 exhibitor passes for each booked stand.

YMENT CONDITIONS

The participation fee is payable 100 percent after having received the invoice. This is valid for all invoices to be send by TOUR. Please care for the expressly stated payment objectives included in the invoice by TOUR, and please care for the bank accounts stated on the invoice.

CANCELLATION / CANCELLATION FEES

If the stand is canceled after written confirmation of the stand proposal, the full participation fee is due, provided the stand cannot be rented out. Should the TOUR be able to rent out the stand at the full participation fee, a cancellation fee of 25% of the participation fee will be charged.

In the event of non-appearance, an additional EUR 500.00 may be incurred for designing the empty stand space in a manner suitable for the trade fair, unless the exhibitor can prove that the TOUR suffered less damage.

ACTIONS DURING THE FAIR / ADDITIONAL CONDITIONS

Registration: Admission only applies to registered companies with the registered products and obliges the exhibitor to exhibit the registered products for the entire duration of the FAIR and to keep the stand manned.

Raffles: tombolas, competitions, quizzes, competitions, giving away freebies, etc. must be registered with the TOUR.

Advertising: Advertising of any kind, in particular the distribution of printed advertising matter and addressing visitors, is only permitted within the stand.

Verbal agreements: Verbal agreements that go beyond this contractual framework are only valid after written confirmation.

All sound reinforcement, background music as well as shows and actions are subject to approval by the TOUR. Even with approval, the TOUR retains

right of withdrawal. Especially when other exhibitors feel disturbed in their advisory and sales talks. Voice amplifiers are only to be used in consultation with the TOUR; the TOUR reserves the right of withdrawal.

Exhibits: Goods that have not been registered must be removed from the stand by the exhibitor. There is no competitive exclusion.

Serving and catering: Due to the special features of the space, serving drinks and serving food to visitors to the stand are generally not permitted. Exceptions to this rule require written approval.

Disposal of materials: The exhibitor must properly dispose of the materials he uses at the stand after the end of the FAIR or take them with him.

Domiciliary rights: The employees commissioned by the Rheintal-Kongress-Zentrum, in particular the caretaker, exercise domiciliary rights over the exhibitors. The staff of the Rheintal-Kongress-Zentrum, the police, the fire brigade and the supervisory authority must be obeyed at all times. The Places of Assembly Ordinance (VstättVO) of the state of Rhineland-Palatinate applies.

LEGAL NOTICE

Violation of exhibition conditions: In the event of gross violations of exhibition conditions, the TOUR can close a stand immediately and carry out the eviction itself without the need for judicial assistance. This applies in particular to advertising that violates legal regulations, morality or the purpose of the trade fair, as well as advertising for ideological or political purposes.

PLACE OF FULFILLMENT

SEVERABILITY CLAUSE

If a provision of this contract is not legally effective in whole or in part or later loses its legal effectiveness, this shall not affect the validity of the remaining provisions. Instead of the invalid provision, another appropriate provision should apply by way of adjustment, which comes as close as possible to the invalid provision in economic terms.
